# General Athlete Policies

## BULLYING POLICY

The California Allstars program is committed to providing athletes with a positive, safe and secure environment in which they can train and progress in the sport of cheer in our facilities. The California Allstars strongly maintains a zero tolerance policy on bullying.

Social Bullying is a form of emotionally aggressive bullying behavior, sometimes referred to as indirect aggression, relational aggression, or covert bullying. This form of bullying often occurs behind the person's back, or it can take the form of public humiliation. Examples are purposely leaving someone out of an activity, telling others not to be friends with someone, spreading rumors, etc.

All instances of bullying should be reported to coach.

## ATHLETE / PARENT / STAFF CODE OF CONDUCT POLICY

Your coaches and Team Reps are here to work with you. You are expected to show respect and be courteous to your coaches, team reps and teammates at all times. Negative comments made on any social forum websites such as, Facebook, Twitter, Instagram, Snapchat, etc. about any member of the California Allstars teams/staff/ reps, competitions or other fellow gyms will result in dismissal from the program. Do not post any pictures of yourself or others, in a California Allstars uniform or attire behaving in a negative or unflattering manner that would reflect negatively on you, your family or the program. Cell phones are not allowed during practice or competition warm-ups. Cell phones must be left in your purse/book bag inside the cubbies. Cell phone use during practice is strictly prohibited, even on breaks.

## ADULT ATHLETES AND MINOR ATHLETE COMMUNICATION

The California Allstars strictly adheres to the USASF's Electronic Communication Policy. An adult athlete affiliated with our program may have a personal social media page or site, with the following restrictions regarding athletes:

- May not invite or allow a minor athlete to "friend" or join a personal social media site or similar online community that is not observable or open to the minor's parent as well .
- May not "private" or "instant" message athletes on any social media or electronic communication platform.
- Must inform parents and athletes that the above is not permitted.
- Social media accounts that allow an athlete to "friend" or "follow" or have no privacy restrictions may only have posts that are appropriate for minors to view.
- Any adult may not directly message a minor athlete participant. All contact must be initiated to the parent, adult owner or adult coach.

## COPYRIGHT NOTICE AND WARNING

Parents and Athletes cannot sell or create their own California All Stars CLOTHING OR MERCHANDISE for personal use or for sale. This includes the use of team names, and any likeness to logo, affiliation and/or program. Any violation, will result in dismissal from the entire program. All CALI clothing will be facilitated through pre-orders, pro-shop and our official online stores. Parents/Athletes/Staff wishing to enter a contest, while wearing the CA uniform, or representing The California All Stars in any media, must first receive permission from the Owner.

## EXCUSED ABSENCES

- Contagious illness and/or flu-like symptoms

- School function that affects your grade
- Family emergencies
- Vacation during summer

## TARDIES

Being late is not acceptable. Learning to be on time is respectful to your teammates and coaches. Developing a habit of being on time will help to set you up for long-term success during your life.

## VACATIONS

Vacations are not permitted during competition season, unless the gym is closed and the athlete has already cleared it with their coaches. Please see your coaches with any vacations at any time. Also, any summer vacations must be in writing 2 weeks prior to the missed practice(s).

## INJURIES

If an injury should occur, we will contact the parent and documentation of the incident will be provided. It is the responsibility of the parent to seek medical help if needed and a doctor's note will be required in order to return to sport.

## TRAVEL/COMPETITIONS

During the competition season, cheerleaders will be asked to travel. Some athletes will travel to national events out of the state. In this case, a separate rule sheet is handed out closer to the time of competition. Transportation to competitions located in Southern California is the responsibility of each team member and his/her family. All Team members will wear the warm-ups or CA All-Star clothing to each function. Uniform articles should be packed neatly into your team bag.

## UNIFORMS & ATTIRE

Please keep all CA All Stars Clothing, Warm-Ups and Uniform in good condition. Please report any lost/damaged uniform items to your coach. The cost of replacement will be the responsibility of the cheerleader. Please wear ASSIGNED gear to practice. (No jeans or jean shorts...) NO jewelry to practice. California All Stars assumes NO responsibility of lost jewelry or any valuables.

## TEAM PLACEMENT

All athletes are placed on a team at the discretion of the coaches. Age, experience & ability all factor into placement. Please understand that athletes may be repositioned, moved or replaced at any time at the discretion of the coaches. Any changes are made to benefit the team as a whole.

## PRACTICES

For everyone's safety, parents are not allowed to come onto the floor for any reason.

# General Parent Policies

## COMMUNICATION

As a parent, you will receive information in several ways, such as monthly newsletters and emails from your coach or Team Rep. We use Facebook and Email as tools for communication. We also encourage our families to download California All Stars App for gym updates, as well as industry updates.

## FEES

- A schedule of payments is listed in this handbook. All monthly fees are due the 25th of the month. Please make all payments via iClass. You will receive a monthly statement of your account with all payments listed. (We will invoice you on the 20th of each month.) Please keep all copies in the event of a question or a discrepancy. Please make all checks payable to California All Stars.
- A late fee of \$25 will be assessed for all payments made after the 5th. All other fees are due on the exact due date. You may pay by cash, check, credit card or money order. Parents and responsible adults will be asked to sign a financial contract. Each person signing the contract will be responsible for keeping his/her child's account current. Please make all checks payable to CAC, Inc.
- Monthly Tuition cannot be prorated for any reason.
- Tuition, Choreography, Camp and Nationals fees are non-refundable.
- By the 5th of each month, your account must be up to date. Otherwise, the athlete will be moved to a non-participation position.

## FUNDRAISING

Occasionally, there are opportunities to participate in fundraisers that require your effort outside of cheer. Profits resulting from your help will be directly posted to your account. Any surplus of funds raised can be used as gym credit.

## PRACTICES

- There is a viewing area designated for all parents/friends. Parents/friends are asked to stay in that designated area and not come into the training area. We want your child to get the most out of every practice. In order for this to happen, we need their full attention. If there are distractions, the whole team is affected and may also become a safety issue.
- If a parent or anyone is observed speaking negatively about a team, coach, parent, or athlete, he/she will be talked to and/or asked to leave. If this kind of behavior continues to be an issue, the child will have to be removed from the team. We will not tolerate this type of conduct. If a parent verbally assaults or threatens a student, coach or parent, the family will be dismissed from the program.

## TRANSPORTATION

All transportation/accommodations to local competitions are solely the responsibility of each family. We will make every effort to provide information in a timely manner. However, if a competition is canceled or rescheduled, California All Stars will not be responsible for reimbursement for any reason.

## PARENTAL SUPPORT

- Your dedication and support is just as important to us as it is to your child!
- We encourage all parents to sit together and support all CA teams. Parents are also encouraged to show support by wearing California All Stars clothing to competitions.
- Showing respect for the coaching staff, other teams and hosting organizations is expected, as you are there representing

# Social Media Agreement

PARTICIPATION IN CHEERLEADING AND GENERAL FITNESS ACTIVITIES ENTAILS KNOWN, ANTICIPATED AND UNANTICIPATED RISKS THAT COULD RESULT IN PHYSICAL AND/OR EMOTIONAL INJURY, PARALYSIS, DEATH OR DAMAGE TO YOURSELF AND/OR TO OTHERS. RISKS MAY INCLUDE, BUT ARE NOT LIMITED TO, SLIPPING AND FALLING, LANDING IMPROPERLY, COLLISIONS WITH FIXED OBJECTS, MOVING OBJECTS AND/OR OTHER PEOPLE WHICH MAY RESULT IN SPRAINS, FRACTURES, BREAKS, SCRAPES, BRUISES, DISLOCATIONS AND INJURIES TO HEAD, BACK AND NECK. I ACKNOWLEDGE THAT CHEERLEADING- INCLUDING TUMBLING AND DANCE- COMES WITH THE FOLLOWING KNOWN RISKS THAT INCLUDE BUT ARE NOT LIMITED TO CONCUSSION, PERMANENT PARALYSIS, AND DEATH.

I understand that there are multiple sections to this waiver and will read each section fully. By providing my initials at each clause I acknowledge my understanding and agreement to the foregoing terms.

In consideration of the services provided by CALIFORNIA ALLSTAR CHEERLEADING, INC, a CALIFORNIA CORPORATION (the "GYM") and my desire to spectate and/or participate in the activities and services provided by CALIFORNIA ALLSTAR CHEERLEADING, INC at the GYM today and in the CALIFORNIA ALLSTARS CHEERLEADING, INC and its individual members, managers, directors, officers, agents, employees, volunteers, representatives, servants, predecessors, successors, assigns, affiliated entities, heirs, personal representatives and all other persons, firms, or entities claiming by or through them are hereinafter known as "CALI ALL STARS"):

(a) agree to use the GYM and its facilities in a safe and responsible manner;
